3. If you are able to, please comment on the applicant's research proposal. (Max. 1000 words)

Through communication with me and Prof. Jiang, and comprehensively considering our NSFC project "Research on the Mechanism and Evolutionary Law of Doctor-patient Contradiction in the "Internet+" Environment" and Prof. Jiang's NSFC project "Unethical Behavior in Service Industries: Occurrence, Nature and Extent", the topic of Shu Hui's proposal is finally determined as "Unethical Behavior in the Medical Service Industry under Information Asymmetry: Occurrence, Prevention and Governance". This research project is quite valuable. Unethical medical behavior harms the interests in patients and affects the doctor-patient relationship, which is not conducive to the healthy development of medical service industry. For the first part, a patient network game model towards their cognition and medical information acquisition will be built. By "learning and being influenced" from each other in the treatment process, patient's utility is in the process of dynamic adjustment. Patients make decisions based on their own utility. There is no doubt that their decisions have an impact on doctors' behavior. The second research topic, a doctor network game model towards their medical service behaviour affected from each other will be constructed. Similar to patient network, the behaviour of individuals affects each other in the doctor network. The two subjects mentioned above are connected to the medical service system. Hence, in the third research topic, a game model among four subjects in medical service system under the patient feedback mechanism including the patient, the doctor, hospital and government will be constructed. The research framework of this proposal is relatively clear and the research method is novel, which is a meaningful proposal.
